## NARRATIVE

On 9/30/25 at approximately 1751 hours, I responded to 6 Walnut Way for a report of a juvenile that got hit by a car.

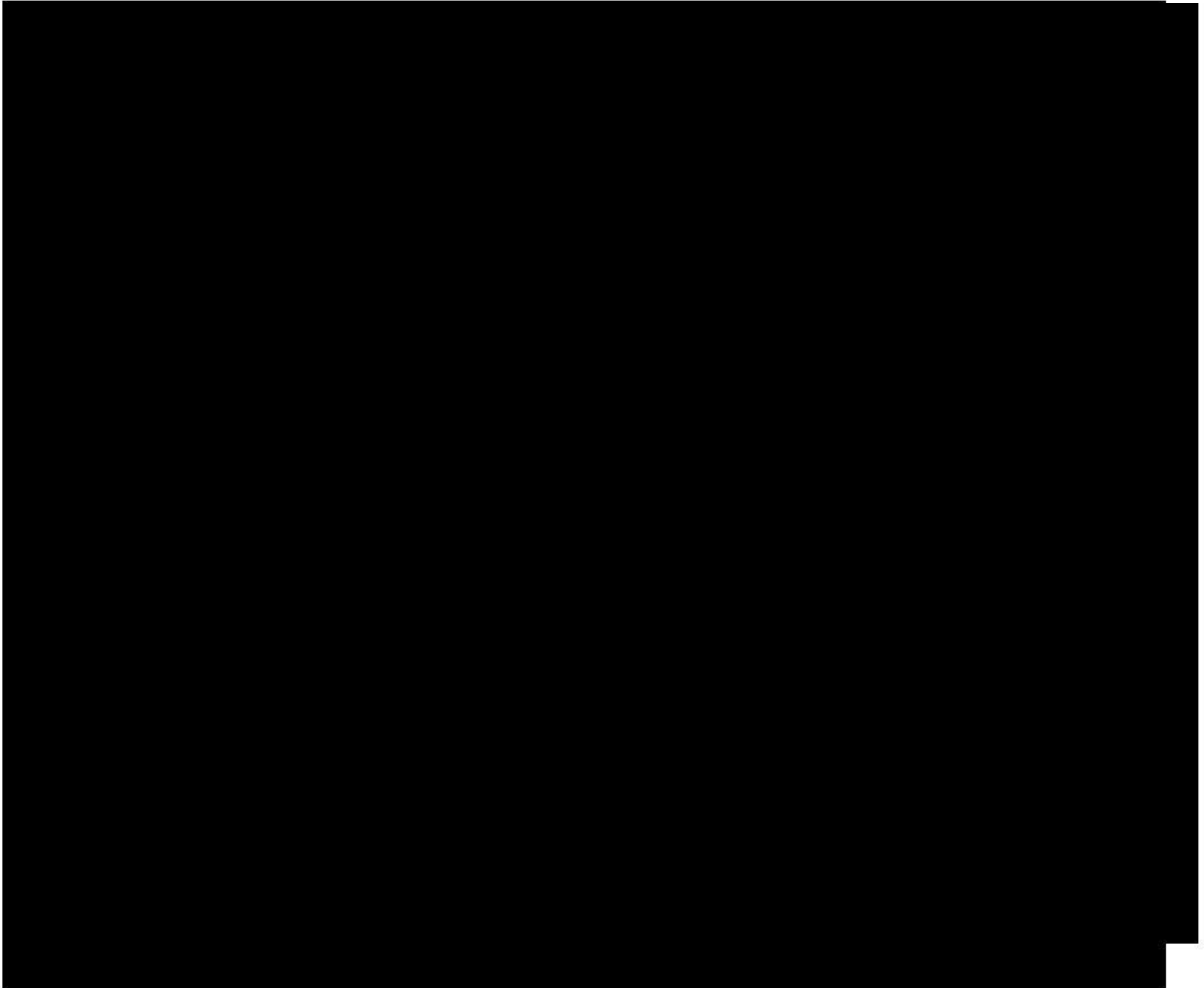

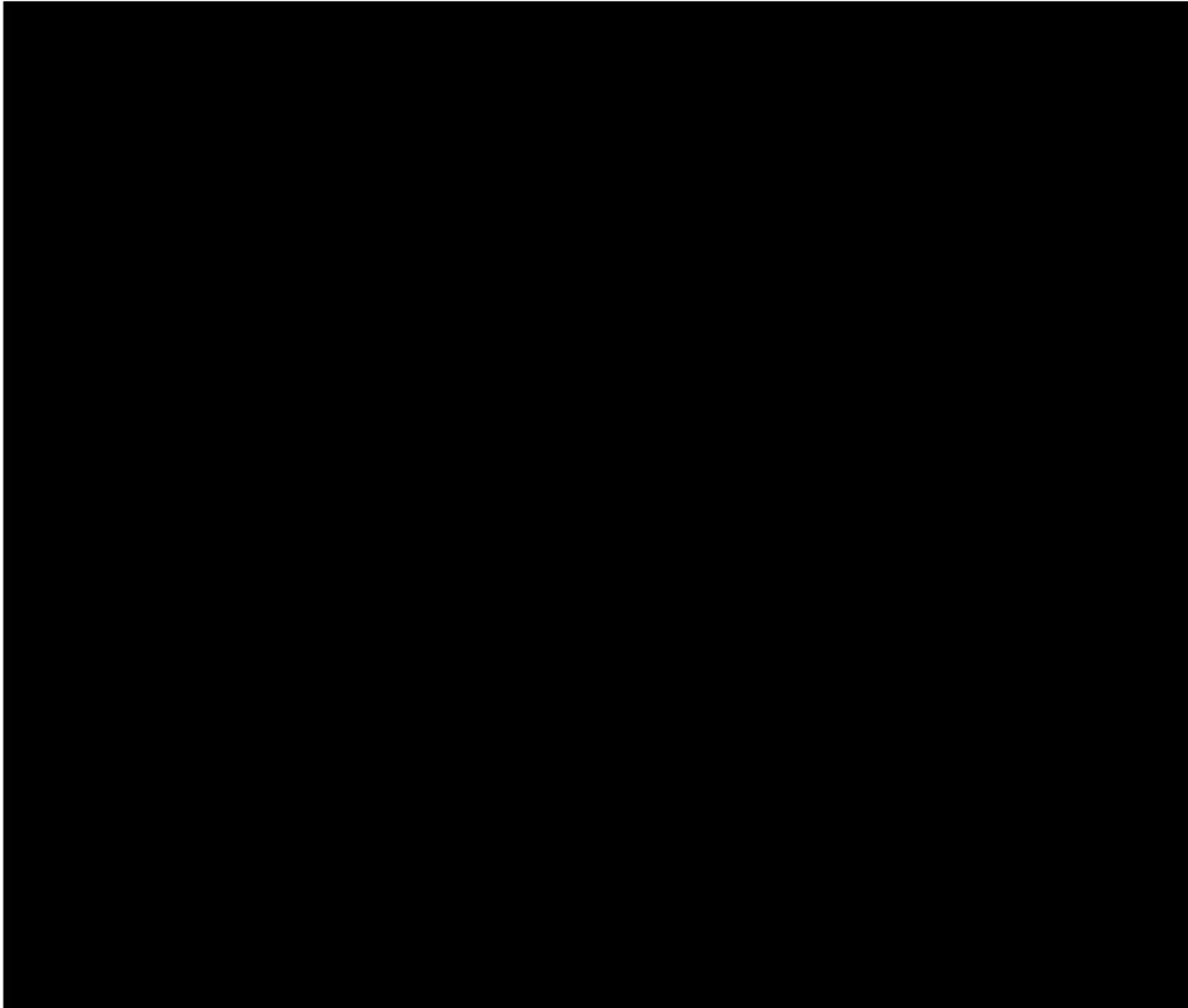
